**WHEREAS,** Environmental Disposal Corporation (Block 59.04, Lot 911) (“the OWNER”) is seeking approval for improvements at the Schley Mountain Road Pump Station; and

**WHEREAS,** the Bedminster Township Land Use Board is scheduled to review the submission of an application for improvements that include an extension of the existing control building, construction of a second wet well and valve chamber to provide redundancy in the system should failure occur, installation of pumping equipment and controls, piping modifications, HVAC and electrical equipment replacement, and other miscellaneous site improvements with no new sewage anticipated as part of the project; and

**WHEREAS,** the project requires Township Committee approval of a Treatment Works Approval (TWA) permit that requires a “Statement of Consent” to be signed by the authorized representative of the Governing Body of the municipality where the project is located; and

**WHEREAS,** Paul Ferriero, P.E. of Ferriero Engineering, Township Engineer for Bedminster Township, has reviewed and approved the attached Statement of Consent as to form and content.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Bedminster, in the County of Somerset, State of New Jersey, as follows:
