WHEREAS, the current Bedminster Tax Collector/Tax Search Officer is retiring effective July 1, 2014; and

WHEREAS, after extensive interviews, the Township Committee has selected Donna Cummins as Interim Tax Collector/Tax Search Officer; and

WHEREAS, Donna Cummins possesses the requisite skill and qualifications set forth in Chapter II of The Revised General Ordinances of the Township of Bedminster, 1984 and N.J.S.A. 40A:9-141, et seq. to diligently perform the duties of the position of Interim Tax Collector/Tax Search Officer; and

WHEREAS, at its Regular Meeting held on June 2, 2014, the Township Committee authorizes the employment of Donna Cummins as of June 16, 2014 and as Interim Tax Collector/Tax Search Officer for the period from July 1, 2014 until January 5, 2015; and

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of Bedminster in the County of Somerset and State of New Jersey, as follows:

1. The employment of Donna Cummins as of June 16, 2014 and as Interim Tax Collector/Tax Search Officer for the term beginning July 1, 2014 until January 5, 2015 is hereby ratified and confirmed.
2. For the work week beginning June 16, 2014 Donna Cummins shall work Monday through Friday between the hours of 8:00am and 4:00pm, working Wednesday afternoons from 1:00pm to 4:00pm in the Far Hills Borough office. The Tax Collector/Tax Search Officer will be paid an annual salary of \$67,000.00.

BE IT FURTHER RESOLVED that a certified copy of this resolution be provided to the Chief Financial Officer, Township Administrator, and Payroll Clerk.
