- Rutgers Coaching Certification Clinic Residents Free, \$35 Non-Residents
- Adult Volleyball \$25 Residents, \$35 Non-Residents
- Kindergarten & 1<sup>st</sup> Grade Girls/Boys Beginner Basketball \$75 per person
- 2<sup>nd</sup>-4<sup>th</sup> Grade Girls/Boys Instructional Basketball \$75 per person
- 4<sup>th</sup>-8<sup>th</sup> Grade Girls/Boys Basketball
  - Recreation Level (with uniform) \$170 per person
  - Recreation Level (w/o uniform) \$125 per person
  - Travel Level (with uniform) \$195 per person
  - Travel Level (w/o uniform) \$150 per person
  - Basketball Jersey Only \$25 per person
  - Basketball Shorts Only \$20 per person
