**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Bedminster that Allison Cavallo is hereby hired as Probationary Police Secretary, in the Police Department with a starting salary of \$45,000, effective January 5, 2015.

**BE IT FURTHER RESOLVED** that following the probationary period of ninety (90) days, the employee, as per 2A-6.8 of the Personnel Policy, shall be evaluated by the Police Chief to determine qualification for regular status.

**BE IT FURTHER RESOLVED** that a certified copy of this resolution be provided to the Police Chief and the Payroll Clerk.
