

EXPLANATION: This resolution authorizes ratifies and confirms the appointment of Donna Cummins as Tax Collector/Sewer Collector/Tax Search Officer.

WHEREAS, the Bedminster Tax Collector/Sewer Collector/Tax Search Officer retired effective July 1, 2014; and

WHEREAS, after extensive interviews, the Township Committee selected Donna Cummins as Interim Tax Collector/Sewer Collector/Tax Search Officer; and

WHEREAS, at its Regular Meeting held on June 2, 2014, the Township Committee authorized the employment of Donna Cummins as of June 16, 2014 and as Interim Tax Collector/Sewer Collector/Tax Search Officer for the period from July 1, 2014 until January 5, 2015; and

WHEREAS, Donna Cummins possesses the requisite skill and qualifications set forth in Chapter II of The Revised General Ordinances of the Township of Bedminster, 1984 and N.J.S.A. 40A:9-141, et seq. to diligently perform the duties of the position of Tax Collector/Sewer Collector/Tax Search Officer, as evidenced by Certification No.: T-8137, and

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of Bedminster in the County of Somerset and State of New Jersey, as follows:

1. The employment of Donna Cummins as of June 16, 2014 and as Interim Tax Collector/Tax Search Officer for the unexpired term beginning July 1, 2014 until January 5, 2015 and shall hold office as Tax Collector/Sewer Collector/Tax Search Officer for a term of four (4) years from the first day of January 2015.
2. The requirement that every municipality shall have a Municipal Tax Collector may be fulfilled by the sharing of the Municipal Tax Collector with another municipality under a shared service agreement entered into pursuant to the provisions of P.L.2007, c. 63 (C.40A:65-1 et seq.).
3. The Township of Bedminster and the Borough of Far Hills have a shared service agreement for the services of Municipal Tax Collector/Sewer Collector/Tax Search Officer as of June 2, 2014 as per Resolution #2014-084.

BE IT FURTHER RESOLVED that a certified copy of this resolution be provided to the Chief Financial Officer, Township Administrator, and Payroll Clerk.
