WHEREAS, the Hamilton Farm Golf Club, Inc. (1040 Pottersville Road) (“the OWNER”) is seeking approval for the Hamilton Farm Gold Club Wastewater Treatment Plant Upgrade; and

WHEREAS, the Hamilton Farm Golf Club, Inc. is seeking the Township Committee to approve a Statement of Consent in order to submit the TWA to the NJDEP as the first step in the approval for the proposed improvements that include the permitted discharge to be increased from 6,696 gpd to 13,000 gpd as part of the project; and

WHEREAS, the project requires Township Committee approval of a Treatment Works Approval (TWA) permit that requires a “Statement of Consent” to be signed by the authorized representative of the Governing Body of the municipality where the project is located; and

WHEREAS, Paul Ferriero, P.E. of Ferriero Engineering, Township Engineer for Bedminster Township, has reviewed and approved the attached Statement of Consent as to form and content.
