RESOLUTION PROVIDING FOR CHANGE OF TITLE OR TEXT OF
AN APPROPRIATION**

WHEREAS, N.J.S.A 40A:4-85 provides that the Director of the Division of Local Government Services may, at the request of, or with the consent of, the governing body of any county or municipality, make such correction of the title, text or amount of any appropriation appearing in the budget as may be necessary to make said item of appropriation available for the purpose or purposes required for the needs of any such county or municipality;

NOW, THEREFORE, BE IT RESOLVED that in accordance with the provisions of N.J.S.A. 40A:4-85, the Township Committee of the Township of Bedminster, in the County of Somerset, State of New Jersey, hereby requests the Director of the Division of Local Government Services to make the following corrections in the budget year 2015:

That the appropriation provided for in the approved budget entitled:

Operations Excluded from CAPS:

Public and Private Programs Offset by Revenues

Body Armor Fund

be reduced by the sum of \$1,834.27

and an appropriation in the like amount of \$1,834.27 be added to the budget entitled:

Operations Excluded from CAPS:

Public and Private Programs Offset by Revenues

Bullet Proof Vest Program

BE IF FURTHER RESOLVED, that the foregoing correction is, in the opinion of the governing body, warranted and authorized by the statute above referred to, and is necessary for the orderly operation of the Township for the reasons set forth:

Awards in the amounts of \$1,765.27 from the N.J. Body Armor Replacement Fund and \$1,834.27 from the Bureau of Justice Assistance BVP Program were received for inclusion in the Township's 2015 budget. The total of these two items was erroneously appropriated as one item, Body Armor Fund, therefore it is necessary to authorize the above correction as well as adjust the anticipated revenue items as noted above.

BE IT FURTHER RESOLVED that the Township Clerk forward two certified copies of this resolution to the Director of Local Government Services for approval
