**WHEREAS,** the Bedminster Township Department of Public Works has determined the need to purchase a stainless steel dump body, hoist and other miscellaneous equipment for a new Ford F-550 recently purchased by that department; and

**WHEREAS,** the Local Public Contracts Law authorizes a municipality to acquire goods and services through the solicitation of at least two (2) competitive price quotations for all contracts that in the aggregate are below the bid threshold of \$36,000, with a Qualified Purchasing Agent, without advertising for bids; and

**WHEREAS,** The Purchasing Agent shall have the authority, responsibility and accountability for the purchasing activity for the Township of Bedminster, to prepare public advertising for bids and to receive bids and requests for proposals for the provision or performance of goods, services and construction contracts on behalf of the Township of Bedminster, and to award contracts permitted through New Jersey statutes and in accordance with the regulations, forms and procedures promulgated by state regulatory agencies in the name of the Township of Bedminster, and conduct any activities as may be necessary or appropriate to the purchasing function of the Township of Bedminster; and,

**NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Bedminster, County of Somerset, that the following award of contract be approved as follows:
