**WHEREAS,** the Township of Bedminster is a party to a cooperative purchasing agreement with the Morris County Cooperative Purchasing, a cooperative purchasing program organized pursuant to the Local Public Contract Law, N.J.S.A. 40A:11-10; and

**WHEREAS,** the Local Public Contracts Law authorizes a municipality to acquire goods and services through a duly formed cooperative purchasing system without advertising for bids; and

**WHEREAS,** the procurement of goods and services through a cooperative program is a “fair and open” process under the New Jersey Pay-to-Play Law, N.J.S.A. 19:44a-20.5 et seq.; and

**WHEREAS,** The Purchasing Agent shall have the authority, responsibility and accountability for the purchasing activity for the Township of Bedminster, to prepare public advertising for bids and to receive bids and requests for proposals for the provision or performance of goods, services and construction contracts on behalf of the Township of Bedminster, and to award contracts permitted through New Jersey statutes and in accordance with the regulations, forms and procedures promulgated by state regulatory agencies in the name of the Township of Bedminster, and conduct any activities as may be necessary or appropriate to the purchasing function of the Township of Bedminster; and,

**NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Bedminster, County of Somerset, that the following award of contract be approved as follows:
