**WHEREAS,** said Director may also approve the insertion of an item of appropriation for an equal amount, and

**WHEREAS,** the Township of Bedminster has received grant awards totaling \$6,258.33 from the NJ Drunk Driving Enforcement Fund Grant and wishes to amend its 2015 budget to include this amount as a revenue.

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of the Township of Bedminster hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of 2015, in the sum of \$6,258.33 which is now available as a revenue from:
