WHEREAS, all of those to be appointed are engaged in rendering "professional services" as defined by R.S. 40A:11-2 (6), in that they are authorized to practice recognized professions, the practice of which are regulated by law; and,

WHEREAS, all of those to be appointed have submitted proposals indicating they will provide the following services; and,

WHEREAS, all of those to be appointed have completed and submitted a Business Entity Disclosure Certification which certifies that the following named professionals and organizations have not made any reportable contributions to a political or candidate committee in the Township of Bedminster in the previous one year, and that the contract will prohibit the following named professionals and organizations from making any reportable contributions through the term of the contract; and,

WHEREAS, the Township Treasurer has certified that sufficient funds are available in the Township budget to pay for the professional services authorized herein,
