WHEREAS, the bid proposals and corresponding documentation submitted by all bidders were reviewed and approved by the Township Attorney and Purchasing Agent as to legal compliance; and

WHEREAS, this contract has been awarded pursuant to a “fair and open process” pursuant to N.J.S.A. 19:44A-20.4, et seq.; and

WHEREAS, the Township Chief Financial Officer has certified that the funds are available in the budget for this project under line item appropriations or ordinance number #2015-02 and #2016-02.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Bedminster, in Somerset County, New Jersey, that the contract for the Base Bid and Alternate Bid #1 for the Bedminster Township Old Dutch Road East Improvements Project be and hereby is awarded to Z Brothers Concrete Contractors, Inc., in the amount not to exceed \$364,885.69.

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Township Committee of the Township of Bedminster, in Somerset County, New Jersey, that the Mayor and Township Clerk are hereby authorized to execute the contract with Z Brothers Concrete Contractors, Inc., in the amount not to exceed \$364,885.69 for the Base Bid and Alternate Bid #1 pursuant to the terms and conditions of the specifications for this project.
