

**EXPLANATION:** This Resolution authorizes the Mayor and Township Clerk to renew an Interlocal Agreement between the Township of Bedminster and the Borough of Peapack and Gladstone for Senior Van Transportation Service.

**WHEREAS,** the Township of Bedminster wishes to continue participation in a shared service agreement with the Borough of Peapack & Gladstone to provide Senior Van Transportation Service to senior citizen residents of the Borough of Peapack & Gladstone; and

**WHEREAS,** the Township of Bedminster and the Borough of Peapack & Gladstone have set forth their respective responsibilities regarding the provision of the services in an agreement between the two municipalities, a copy of which agreement is annexed to this resolution; and

**WHEREAS,** the shared services agreement has been reviewed and approved by both the Township of Bedminster and the Borough of Peapack & Gladstone.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Bedminster in the County of Somerset and State of New Jersey, as follows:

1. The Mayor and Township Clerk are hereby authorized and directed to execute the agreement to provide Senior Van Transportation Service to the Borough of Peapack & Gladstone. Said Agreement is annexed hereto as Exhibit A.
2. Upon execution of the Agreement by the Township of Bedminster, the Township Clerk shall forward said agreement to the Borough of Peapack and Gladstone for execution by the Township Council.
3. This agreement shall expire December 31, 2016.
4. The Borough of Peapack & Gladstone shall pay the Township of Bedminster a per diem rate for this service of \$15 per day per rider to be paid on July 1, 2016, and December 1, 2016.
