

EXPLANATION: This resolution authorizes the award of a contract to H. W. Alward, Inc. pursuant to Local Public Contracts Law, N.J.S.A. 40A:11-6.

WHEREAS, the Local Public Contracts Law authorizes a municipality to contract without public bid advertising for bids when an emergency affecting the public health, safety or welfare requires the immediate delivery of the articles or performance of the services pursuant to N.J.S.A. 40A:11-6; and

WHEREAS, an emergency condition has arisen in the Township of Bedminster with respect to repairs and/or improvements needed for the Sanitary Sewer Collection System (“SSCS”) and an emergency appropriation has been provided within the Sewer Utility Operating Fund through Resolution #2016-042 to fund such repairs and/or improvements; and

WHEREAS, The Purchasing Agent shall have the authority, responsibility and accountability for the purchasing activity for the Township of Bedminster, to prepare public advertising for bids and to receive bids and requests for proposals for the provision or performance of goods, services and construction contracts on behalf of the Township of Bedminster, and to award contracts permitted through New Jersey statutes and in accordance with the regulations, forms and procedures promulgated by state regulatory agencies in the name of the Township of Bedminster, and conduct any activities as may be necessary or appropriate to the purchasing function of the Township of Bedminster; and,

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Bedminster, County of Somerset, that the following award of contract be approved as follows:
