WHEREAS, the Township Chief Financial Officer has certified that the funds are available in the budget for this project under line item appropriations or ordinance number #2015-10.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Bedminster, in Somerset County, New Jersey, that the contract for the Base Bid for the Bedminster Township Robertson Drive Resurfacing Project be and hereby is awarded to Konkus Corporation in the amount not to exceed \$107,884.20.

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Township Committee of the Township of Bedminster, in Somerset County, New Jersey, that the Mayor and Township Clerk are hereby authorized to execute the contract with Konkus Corporation in the amount not to exceed \$107,884.20 for the Base Bid pursuant to the terms and conditions of the specifications for this project.
