

Explanation: This Resolution authorizes the insertion of a special item of revenue and insertion of an item of appropriation for equal amount in the 2016 Budget to include funding for the Drive Sober or Get Pulled Over 2016 Statewide Crackdown Grant.

WHEREAS, N.J.S. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget, and

WHEREAS, said Director may also approve the insertion of an item of appropriation for an equal amount, and

WHEREAS, the Township has received additional grant awards totaling \$4,250.00 from the National Highway Traffic Safety Administration for the purpose of the Drive Sober or Get Pulled Over 2016 Statewide Crackdown program, and wishes to amend its 2016 budget to include this amount as revenue.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Bedminster hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue from:

Miscellaneous Revenues:

BE IT FURTHER RESOLVED that a like sum of \$4,250.00 be and the same is hereby appropriated under the caption of:

Public and Private Appropriations Offset by Revenues:
Drive Sober or Get Pulled Over
2016 Statewide Labor Day Crackdown Grant = \$4,250.00
