Bedminster Recreation is teaming up with the New Jersey Audubon Scherman Hoffman Wildlife Sanctuary to offer Fishing Camp for children entering 4th grade or older. Fishing Camp will cover all the basics from gear, bait and lures to proper fish handling and conservation ethics. Campers are required to bring their own gear: Rod, Reel and Tackle Box.

Campers will meet daily at Bedminster's **Miller Lane Park** under the tent in our outdoor classroom and begin their fishing adventures there accessing the North Branch of the Raritan River and The Bedminster Pond. **Transportation will be provided to Miller Lane Park from Camp Bedminster daily for Camp Bedminster & Lunch Bunch registrants only!** Parents are to pick-up promptly at 4 p.m. at Miller Lane Park. We will be meeting rain or shine. In case of severe inclement weather, Fishing Camp will meet in the Bedminster Town Hall located at One Miller Lane. Curb side pick-up will then be at the side entrance to town hall.

Please dress your child comfortably and appropriately for outdoor adventure. No sandals! Bug spray and a hat are suggested as we will be using the nature trails and Hike and Bike trail to access fishing areas. **Be sure to bring plenty of beverages in a refillable container!** The fee for Fishing Camp is \$150. Registration is very limited.
