

# **Bulky Waste Disposal 2022 Schedule**

The fee for a Bulky Waste Permit is \$10 per visit with a maximum of four (4) visits per 12-month registration cycle. Additional visits may be purchased at \$15 per visit with a maximum of two (2) additional visits per 12-month registration cycle. These additional uses will expire one year from the initial permit date of application.

The Dump is located on Miller Lane and is open on the following days and times:

- 1st Thursday of the month 8:00 AM to 11:00 AM
- 4<sup>th</sup> Saturday of the month 7:00 AM to 2:00 PM (From March 1<sup>st</sup> October 31<sup>st</sup>)

(November - February the facility will **NOT** be open on Saturdays)

# **Bulky Waste Rules & Regulations:**

#### Who can apply for a Bulky Waste Permit?

- 1. Any township resident
- 2. Any tenant of a rented property (provided that the rental property is their primary residence)
- 3. Commercial property owners or tenants **DO NOT** qualify

### Acceptable Proof of Residency:

- 1. Driver's license
- 2. Property tax bill
- 3. Voter registration card

#### How can I Apply?

#### **Acceptable Vehicles:**

Passenger vehicles, pick-up trucks and SUVs. Open trailers with no more than 1 axle will be accepted. No box trucks, dump trucks, rack body trucks or enclosed trailers permitted.

#### Acceptable Bulky Waste Items:

Bulky Waste is defined as JUNK, non-recyclable materials such as furniture, mattresses, toys, carpeting, house hold appliances (refrigerators and freezers must have the doors removed), vehicle tires (without rims), electronics, latex paint (ONLY if paint is dried out), and fencing.

## **Unacceptable Bulky Waste Items:**

Recyclable Items: cardboard, newspaper, glass, plastic, etc.

Hazardous Materials: oil based paints, florescent tubes, gasoline, kerosene, diesel fuel, pesticides, household & vehicle products (antifreeze, transmission fluid, brake fluid, used oil filters, car batteries), propane tanks, appliances with refrigerant (unless tagged by authorized appliance technician as having been removed).

Other: household garbage, contractor, industrial or business materials.

#### **Acceptable Vegetative Waste:**

Tree branches that do not exceed more than 6 feet in length and 6 inches in diameter. Leaves (MUST be removed from branches and bagged at the time of disposal).

#### **Unacceptable Vegetative Waste:**

Grass clippings, stumps, roots, hay or firewood.
